WHAT IS AN UNRESTRICTED FUND?

None of us can predict the future needs of our community. An unrestricted fund is the most responsive to our communities' needs.

Unrestricted funds provide the opportunity and flexibility to fund changing needs, and assure that grants will be available in perpetuity for the most current needs of our community.

WHAT IS AN AREA OF INTEREST FUND?

An area of interest fund is a permanent fund that enables the donor to focus resources in one area of interest. Some examples are: arts and culture, early education, environmental stewardship, and health and human services. These dollars are awarded through competitive grantmaking annually to assure our community's needs are being met today and tomorrow.

HOW WILL MY CONTRIBUTION HELP?

Your contribution will ensure that TFEC has a readily available pool of monies that nonprofits can leverage to address current community needs through a competitive grantmaking process. In 2020 we awarded **\$758,263** in competitive grants and were still unable to fund all requests.
